



W.I.T.S. Renewal Requirements Easy Steps To Renew

The W.I.T.S. certification is valid for a two-year period. In order to ensure that our certified professionals are keeping up to date and current on the latest fitness industry knowledge, W.I.T.S. requires that the following steps be taken towards renewal of your certification. These requirements should be completed and submitted prior to your expiration date.

1. A minimum of 10 continuing education credits (CECs) must be accumulated by attending W.I.T.S. approved workshops, home study courses and seminars. Other approved providers and college credit courses may apply for this requirement. For a complete listing of approved providers, please visit our website.
2. Completions of at least one Mandatory W.I.T.S. live workshop presentation or home study CEC course. This course must be administered through W.I.T.S.; approved providers do not apply for this requirement.
3. Proof of a current CPR & AED certification.
4. W.I.T.S. Renewal Forms (#RN001 & #Rn002) filled out completely with renewal fee.

To maintain your W.I.T.S. certification as a professional fitness instructor, you must complete 10 Continuing Education Credits (CEC's) within your two-year renewal period. Of those continuing Education Credits, at least 5 must be of lecture/research format. (i.e.; many home studies are considered lecture/research formats.) (Please refer to CEC Form# RN002) In addition, you must complete at least 1 mandatory WITS CEC program.

In order to renew your certification, the following items must be sent to W.I.T.S.:

- Completed Renewal Forms #RN001 & RN002
- Copy of Completed 10 CECs to include mandatory 1 WITS CEC Program
- Copy of current CPR/AED certification
- Renewal fee

In order to obtain a current certification through W.I.T.S., you must acquire 10 Continuing Education Credits (CEC's) for every 2-year period starting with the date on your certificate. **When renewing, at least (1) WITS CEC program must be at completed through a live college presentation or through the at-home study DVD collection.** The remainder of the CECs can be acquired though other approved organizations and certifying agencies. A minimum of 5 CEC's must be lecture/research format. The World Instructor Training Schools will also accept CEC's from workshops and lectures approved by W.I.T.S., Colleges, ACSM, AEA, ACE and AFAA providers.

Before submitting your renewal, please ensure you have included all the following requirements: Renewal Forms RN001 & RN002, proof of completed CECs with WITS CEC program, proof of CPR/AED certification and renewal fees. Please send copies only (originals will not be returned) to:
